Assessment of personal and professional readiness ( <i>including clinical confidence and capability; and appropriate advanced skill interest</i> ) to commence practice in a rural area	Assessed by RGTA at Career Planning interviews (PGY1 & 2) and in consultation with Director of Clinical Training (DCT) at trainee's employing hospital. **Failure to provide evidence of completion of the above items by the deadline nominated will deem a trainee ineligible to be considered for Rural Generalist Medicine Prevocational Certification assessment. This may prevent a trainee from proceeding to Advanced Skills Training or rural vocational placement / QHRSS rural return of service.**

Trainees should also ensure they:

- Have considered, and sought advice from, their Rural Generalist Training Advisor (RGTA) regarding when to apply for general practice training with the Royal Australian College of General Practitioners (RACGP) or Australian College of Rural and Remote Medicine (ACRRM).
- Advise the QRGP team of any change to personal contact details via: [rural\\_generalist@health.qld.gov.au](mailto:rural_generalist@health.qld.gov.au)
- Contact your RGTA if you have any concerns with regards to hospital terms or any other issues requiring advice and support.
- Maintain consistent contact with the QRGP team regarding your career intentions.
- Consider your preferred AST discipline and ensure you are ready to apply for it by April of PGY2 if you want to commence your training in PGY3. The QRGP team will provide more information and reminders closer to the time.
