

QRGP Swapping and Withdrawal Guide

The Queensland Rural Generalist Pathway (QRGP) is committed to ensuring recruitment, selection and balloting processes are undertaken in a fair and equitable manner and follow due process.

Purpose

To outline the process that occurs when a QRGP trainee requests to swap their intern hospital allocation or declines the offer of a QRGP intern position.

Scope

This guide applies to all final year medical students who have been successful in their application to join the QRGP and are due to commence internship the following year.

Swap

Should a QRGP trainee wish to swap Rural Generalist Training Hospitals, the following terms and conditions apply:

- The swap **must** be completed by 1 November in the year prior to commencement of internship.
- A swap can **only** occur between QRGP interns. A swap can not occur between a QRGP intern and a general intern; or a QRGP intern and a postgraduate year two or more QRGP trainee.
- The swap must not result in a vacancy at either intern's original hospital. A QRGP intern wanting to swap out of hospital A to hospital B must swap with another QRGP intern who wants to swap from hospital B to hospital A.
- QRGP trainees must provide the QRGP team with written notification of their request to swap and include confirmation of their allocated training hospital and their desired hospital.
- The QRGP team will maintain a register of requests to swap hospitals and will only contact parties whose request to swap matches.
- The medical recruiters at both hospitals must be approached for consent and must provide written approval to the QRGP team endorsing the swap. Submission of this evidence is the responsibility of the QRGP trainees requesting to swap. A swap cannot proceed without this evidence.
- The swap will only be upheld while all parties continue to support the agreement and if each QRGP trainee reports for duty at the hospital they agreed to. If one party fails to commence duty at the hospital to which they swapped, the other party may be required to fulfil their intern year at their original hospital allocation.
- Submission of a request to swap by a QRGP intern constitutes implied consent for the QRGP team to provide contact details between parties who may be eligible to swap.
- Submission of a swap request does not place any liability or onus on the QRGP team to ensure a swap occurs.

Withdrawal

Should a QRGP trainee wish to decline their offer of a QRGP intern hospital allocation after accepting a position on the Pathway, the following terms and conditions apply:

- The applicant will forego their QRGP intern status and be withdrawn from the QRGP.

- The applicant will not be considered for any other Intern position in Queensland for the intended year of internship.
- The applicant may be allocated a priority status of Group D in subsequent application years.
