Aboriginal and/or Torres Strait Islander QRGP Intern Allocation Initiative Guide

The Queensland Rural Generalist Pathway (QRGP) has adopted the following definition from the 2018 Closing the Gap Performance Report:

Indigenous is used in this document to describe a person of Aboriginal and/or Torres Strait Islander descent who identifies as an Aboriginal person or a Torres Strait Islander, and is accepted as such by the community in which he or she lives (Queensland Health, 2018).

The QRGP recognises the unique position of Aboriginal and/or Torres Strait Islander peoples in Australian culture and history; and their deep connection to the land.

In Queensland the life expectancy gap between Indigenous and non-Indigenous residents is currently estimated at 7.8 years for males and 6.7 years for females. The ongoing national commitment to improving Aboriginal and/or Torres Strait Islander health necessitates a workforce which is culturally capable and appropriate; and based in communities in need. While it is the responsibility of all health professionals to provide culturally sensitive care, it is important that the number of Aboriginal and/or Torres Strait Islander people choosing a career in health is prioritised.

Purpose

The purpose of this initiative is to promote the success of Aboriginal and/or Torres Strait Islander medical graduates in the Queensland rural and remote workforce. Eligible Rural Generalist applicants can apply to the Aboriginal and/or Torres Strait Islander QRGP Intern Allocation Initiative to be allocated to their first preferenced hospital. The only exception to this is when the number of approved Aboriginal and/Torres Strait Island Intern Allocation Initiative applications is greater than the number of facility positions available. In this instance an exemption ballot will take place prior to the main ballot.

Eligibility

Applicants wishing to access the QRGP Aboriginal and/or Torres Strait Islander Intern Allocation Initiative must:

- be of Aboriginal and/or Torres Islander descent; **or** accepted as an Aboriginal and/or Torres Strait person by the Aboriginal and/or Torres Strait Islander community in which they live
- meet QRGP's eligibility criteria
- meet QRGP's suitability requirements during the selection process
- be a Group A or Group B applicant

Eligible applicants who wish to participate in the Initiative are required to submit documentation as outlined in the supporting documentation section below, as part of their online application. Late applications and change of location requests will only be considered in exceptional circumstances ie. due to an event which has occurred since applying, for example, medical reasons.

Rural Generalist applicants can only make application to **one** of the following:

- Special consideration
- Joint ticket
- Aboriginal and/or Torres Strait Islander Initiative

Application

On the applicants QRGP Intern application, at Step 3 - Other Details applicants need to:

- Select 'Aboriginal and/or Torres Strait Islander Intern Allocation Initiative'
- Advise which hospital the applicant wishes to work at

Note: Please ensure that the hospital nominated in this section is the same as the first preference in the preferences section of the intern application.

After applications close, applicants will receive an email that advises the due date and method of submission for supporting documentation.

Applicants will be notified of the outcome of their application when first round offers are released.

Supporting documentation

Applicants must provide:

- A declaration of Aboriginal and/or Torres Strait Islander descent (a signed statutory declaration is an acceptable form of declaration for this purpose; or
- Confirmation of acceptance as an Aboriginal and/or Torres Strait Islander person by the Aboriginal and/or Torres Strait Islander community in which they live (such information must be provided by an incorporated community organisation, association or body where the majority of members of the governing body are Aboriginal and/or Torres Strait Islanders or both. The confirming organisation must exist at the time of the intended purpose of the confirmation. An original or notarised copy of a 'letter of confirmation', is an acceptable form of confirmation for this purpose); and
- A statement as to why the applicant wants to work at a particular hospital

All documents must be certified by a Commissioner for Declarations, Justice of the Peace, Solicitor (or other approved delegate) as true copies of the originals.

Review of applications

Applications will be assessed by the interview panel prior to the ballot process.

The panel will consist of the following members:

- Representatives of Queensland Rural Generalist Pathway
- Representative of Darling Downs Health Indigenous Health

The panel will review the documentation provided to confirm the eligibility of applicants to be allocated to a QRGP intern position under the Initiative. The Panel may contact applicants if any additional information is required for the application to be properly considered.

The panel will offer endorsement of applications to the QRGP Intern ballot and special consideration committee, which will confirm the applicant's exemption from the ballot process.

If there are more eligible applicants than positions available at a particular facility, merit order of applicants will be considered.

Applicants who have been confirmed as eligible by the panel will be exempt from the initial ballot process.
